



Article 166 of the Law 20/2015, on July 14, of management, supervision and solvency of insurance and reinsurance undertakings, stipulates that the supervisory authorities of other European Economic Area Member States must be informed of the adoption of certain special control measures affecting insurers.

Pursuant thereto, you are hereby notified that on 27 Jun 2016, the Directorate General of Insurance and Pension Funds delivered a Resolution in connection with LA ALIANZA ESPAÑOLA S.A. DE SEGUROS which includes, among others, the following terms:

1. To adopt the special control measure specified in paragraph of Article 160.1.c) of the Law of management, supervision and solvency of insurance and reinsurance undertakings, consisting in prohibiting LA ALIANZA ESPAÑOLA S.A. DE SEGUROS from disposing of or drawing on its real estate, securities, current or deposit accounts, financial assets or any other property in its possession.
2. To adopt the special control measure specified in paragraph of Article 160.1.d) of the Law of management, supervision and solvency of insurance and reinsurance undertakings, consisting in prohibiting LA ALIANZA ESPAÑOLA S.A. DE SEGUROS to assume new debts, grant loans or provide guarantees and distribute dividends.
