Result	The ability to evaluate Latvia's progress in attaining climate neutrality objectives as well as the financial sector's role in and contribution to the attainment of those objectives in the transport sector is further improved. The Credit Register collects a new data category "Reference to the financed object", whereby Credit Register participants (including credit institutions and their subsidiaries primarily providing financial leasing services) provide information on the identification (VIN) number of the financed vehicle. Data characterising the vehicles are obtained from the state joint-stock company "Road Traffic Safety Directorate" in order to determine the climate effect of the vehicles financed by the Credit Register participants. Those data include data on the type of fuel used by the vehicle and its CO ₂ emissions.
